

Regular meeting of the Board of Selectmen convened at 7 p.m. on Tuesday, October 9, 2018 in Room 34, the Harry B. Butters Chambers, Norwood Memorial Municipal Building, with the Pledge of Allegiance, and a silent moment of prayer and reflection. Meeting is Recorded.

#### 7:00 P.M. – Show Cause Hearing, S & H Supreme Norwood Fuel, Inc., dba Supreme Gas, 145 Broadway, Mittesh Patel, Manager:

The Clerk read the notice. Dear Mr. Patel, as Manager of record of the Wine & Malt Beverages Package Store License issued to S & H Supreme, Norwood Fuel Inc., dba Supreme Gas, 145 Broadway, you are hereby given formal notice that the Board of Selectmen, acting as local licensing authority, will hold a show cause hearing Tuesday, October 9, 2018 at 7:00 p.m. in the Selectmen's Chambers, under Chapter 138 of the General Laws to consider whether your license to sell wine & malt beverages should be suspended, limited or revoked for failure to provide the public with the services contemplated by the license as required by M.G.L. Chapter 138 Section 15 and 77. Norwood Board of Selectmen

Attorney Gregory Demakis and Ankit Patel were in attendance. Attorney Demakis explained that Mr. Patel and partners purchased the Beer and Wine license for 145 Broadway where they have a convenience store and gas station and they planned to renovate. The partners had a disagreement and have decided to sell the convenience store, gas station and real estate. They never used the beer and wine license, and there is no excuse for this. They have entered into a purchase and sale agreement to sell the license. The prospective buyer is Ganesh Market, Inc., dba Pam's Market, 210 Pleasant Street. Attorney Hern represents the buyer and plans to file the application to Transfer the License. Attorney Demakis asked that the Board please allow them to transfer the license. Selectman Bishop said there is no excuse for not having used the license. They had an obligation to have alcohol for sale. Selectman Plasko said he was not happy but is willing to give a period of time and supports up to a six month extension. If after six months the license is still in Mr. Patel's possession and not being used, it will be revoked. Selectman Donohue stated she would abstain, as her family owns a package store. Selectman Howard said renewal of licenses is coming up quickly, so this license will have to be renew. Attorney Demakis said they are aware they have to file renewal. Chairman Maloney echoed the sentiments of his colleagues. The license has been out there for a while. The Chairman asked if there was any public comment. Hearing no input from the public, and on motion of Selectman Plasko, seconded by Selectman Bishop, voted 4-0 to continue the hearing for six months. Selectman Donohue abstained.

#### 7:30 P.M. – Doctor Salvatore Perla, President, Norwood Hospital:

Chairman Maloney introduced Dr. Perla. Dr. Perla said he, is very excited to be here and to be at Norwood Hospital. He's getting to learn about the staff, medical staff, and the surrounding communities. He spends a lot of time outside the hospital learning what people are looking for in a community hospital.

Dr. Perla spoke about some of the hospital's new physicians and services, Dr. Timothy Hartshorn, who specializes in shoulders, Dr. Dana Xu, who is a general surgeon, Dr. Tracy Webber, who is an orthopedic surgeon, and Dr. Jaqnaki Patel, who specializes in gastroenterology and Hepatology. Dr. Perla spoke about some of the community services offered by the hospital, such as cancer screenings, health programs, information sessions and support groups. He spoke about the Catheter Lab, which has the best door to doctor time. Norwood is the regional location and they have two cardiac catheter labs.

Selectman Donohue asked Dr. Perla about his background. Dr. Perla said he is a Public Health Doctor, which is different from a Medical Doctor. A public health doctor can focus on treating the community, or work out in the field as an epidemiologist. His career is focused on leadership

and determining the needs of the community. Selectman Donohue mentioned Mr. Usevich, who was present in the audience. Selectman Bishop spoke about Dr. Perla's experience and qualifications.

Dr. Perla spoke about the emergency department at the hospital, which has three departments. Mass General runs the pediatric emergency department, and fast track is for people who do not want to wait. Mr. Usevich introduced Richard Mawn, who is another member of the board.
